# SR A1A Resurfacing, Restoration, and Rehabilitation Project

The Florida Department of Transportation (FDOT) invites the community to a Virtual Public Meeting and Inperson Construction Open House regarding the upcoming SR A1A Resurfacing, Restoration, and Rehabilitation Project. This project aims to enhance safety, resiliency, and longevity of the infrastructure in our communities. Please see below for detailed meeting information.

Construction Cost: \$3.9 Million Construction Start: August 2024 Anticipated Completion: Summer 2025

#### **PROJECT IMPROVEMENTS**

- Mill and repave the existing roadway within project limits to ensure long-term resilience
- Widen the shoulders to provide 4-foot to 8-foot designated bike lanes in each direction of SR A1A from south of the John D. MacArthur State Park entrance to Portage Landing North to enhance bicyclist accessibility and safety
- Reconstruct pedestrian sidewalk curb ramps to meet current Americans with Disability Act (ADA) standards
- Replace the mast arm traffic signal system to meet current hurricane design standards to ensure motorist safety and resiliency
- Upgrade pedestrian signals at signalized intersections to improve push button accessibility
- Upgrade video vehicle detection system and in-road sensors to improve traffic flow
- Upgrade lighting at the Lost Tree Village/Old Harbour Road intersection to enhance motorist and pedestrian visibility
- Upgrade pavement markings and signs to improve visibility and accessibility for motorists

#### TRAFFIC IMPACTS

- Work will occur in phases to minimize impacts to the public and the posted speed limit of 45 mph will be reduced to 35 mph in the work zone
- Lane closures are permitted 24/7 from Sunday to Saturday, except at the signalized intersection of Old Harbour Road/Village Road and SR A1A, where closures are not allowed from 7:00 a.m. to 12:00 p.m. Flaggers will direct traffic as needed.
- Nighttime construction activities are not allowed from 8:00 p.m. to 7:00 a.m. between the St. Paul of the Cross Catholic Church entrance and Portage Landing North
- Milling and resurfacing at the John D. MacArthur State Park entrance is allowed nightly, Sunday through Saturday from 8:00 p.m. to 7:00 a.m. Flaggers will direct traffic as needed
- Pedestrians will be redirected to a temporary pathway along the west side of the roadway at the St. Paul of the Cross Catholic Church entrance and exit, Lost Tree Village service entrance, and at the intersection of Old Harbour Road/Village Road and SR A1A
- Access to businesses and residences will be maintained at all times
