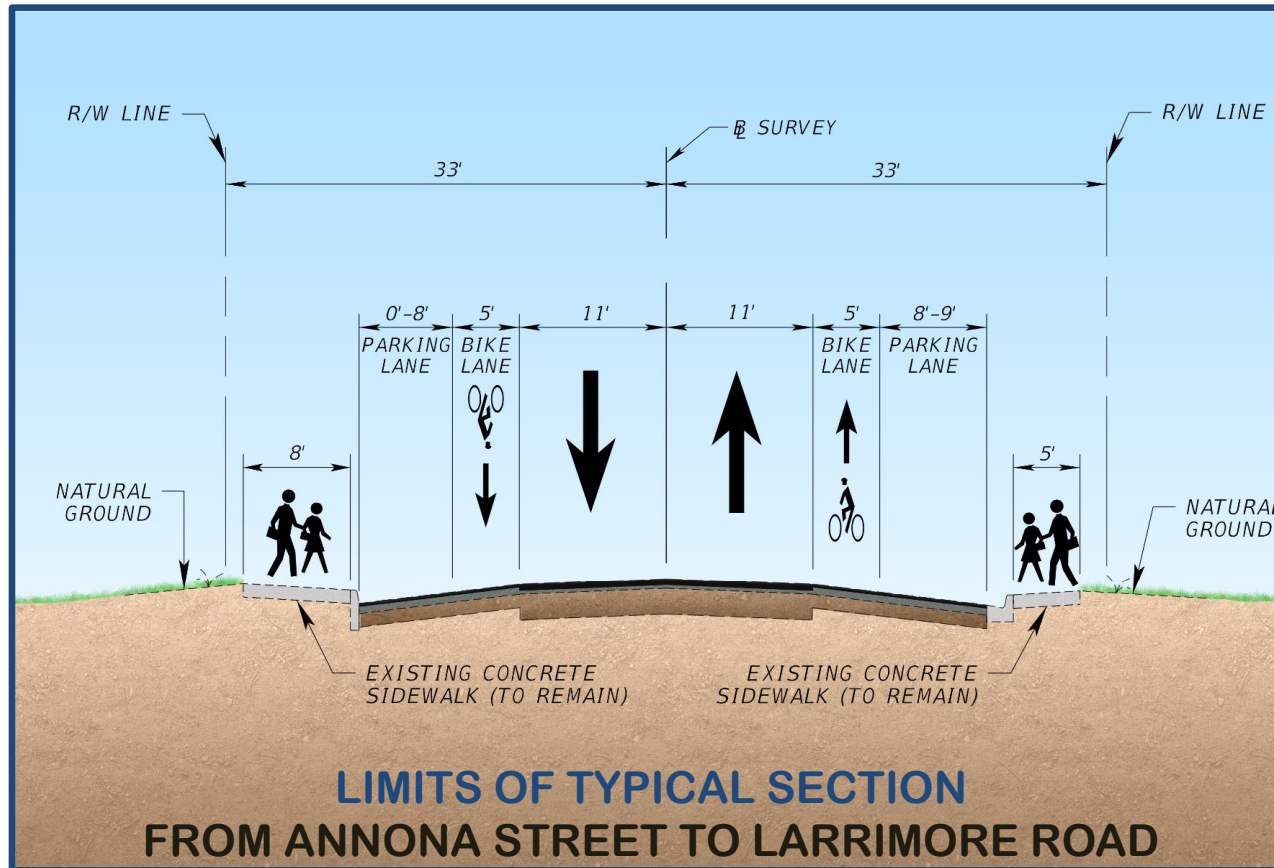
Proposed Improvements:

- Upgrade lighting at the existing midblock crosswalks

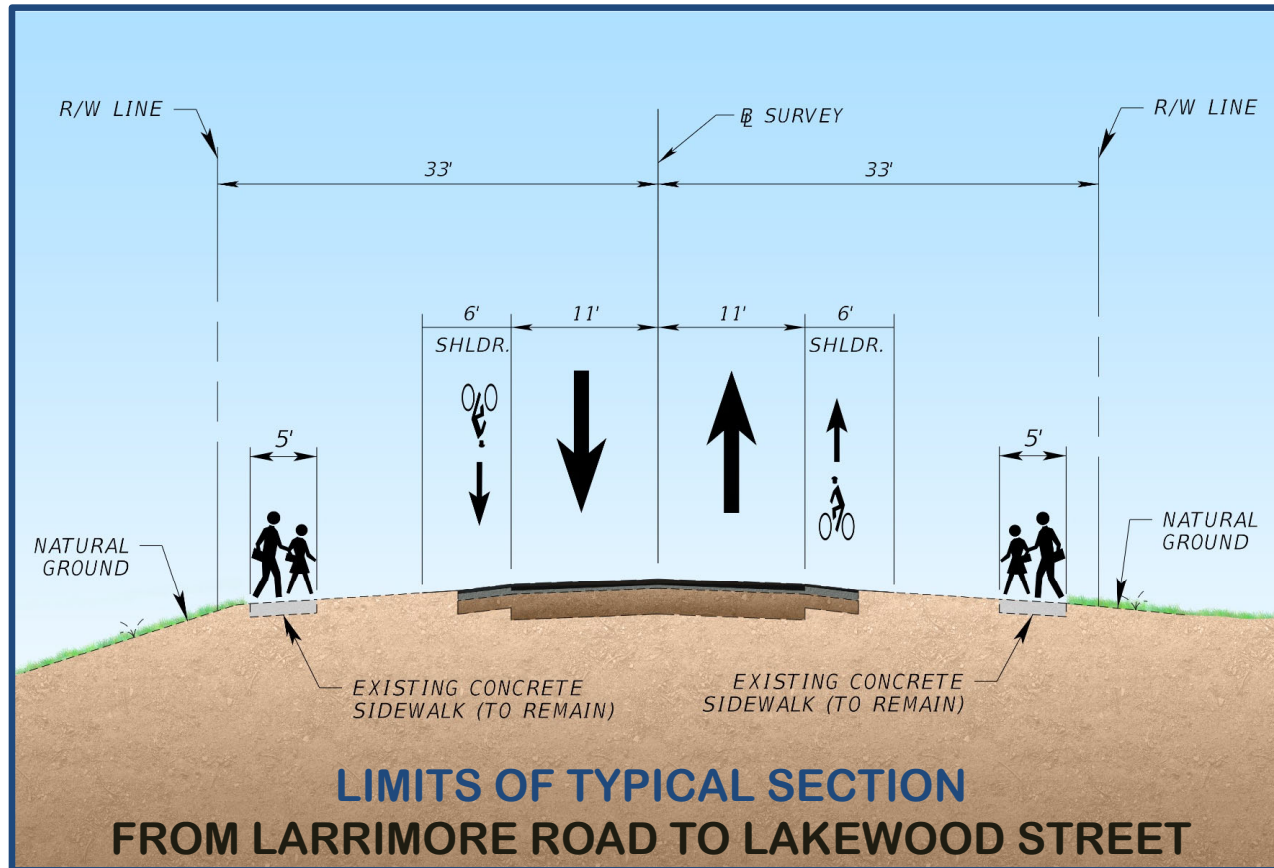

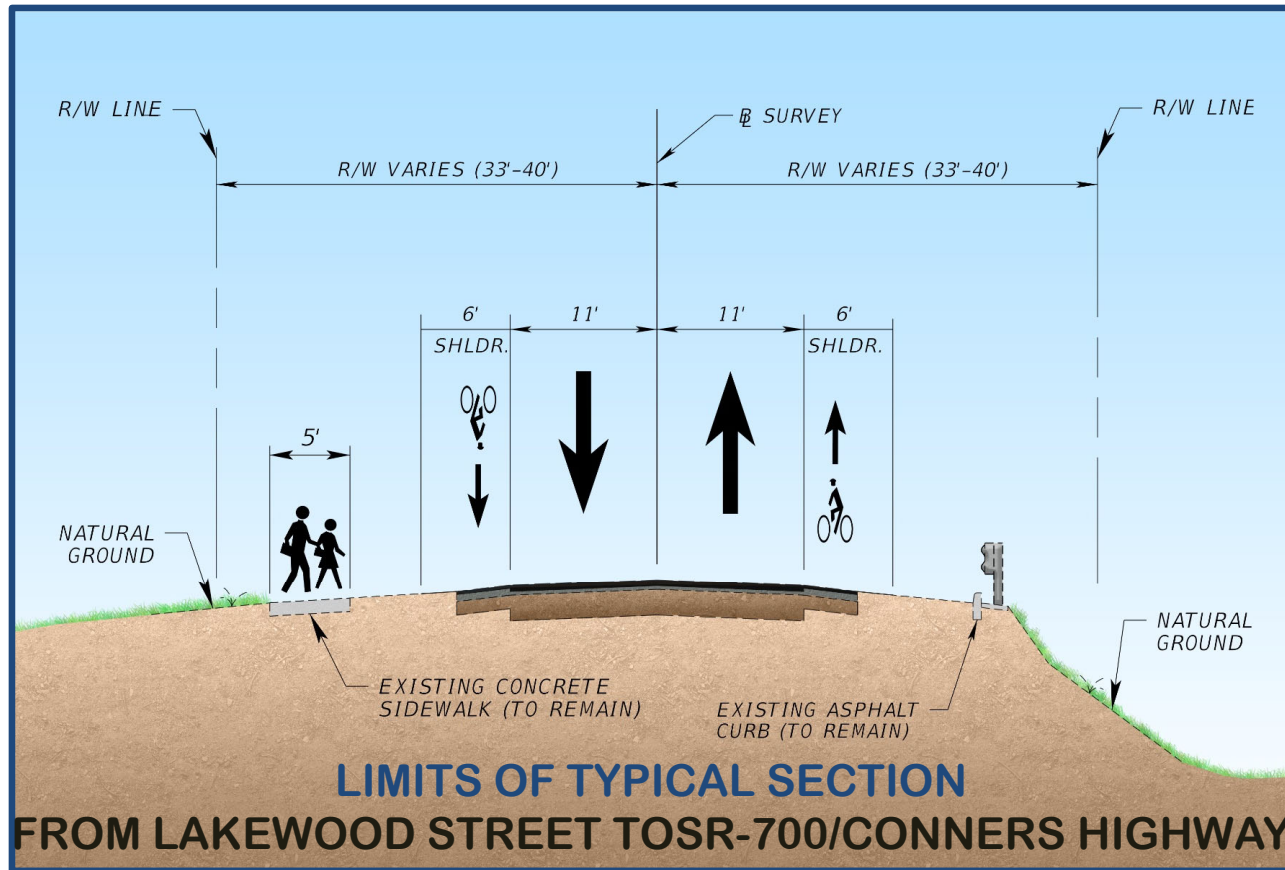

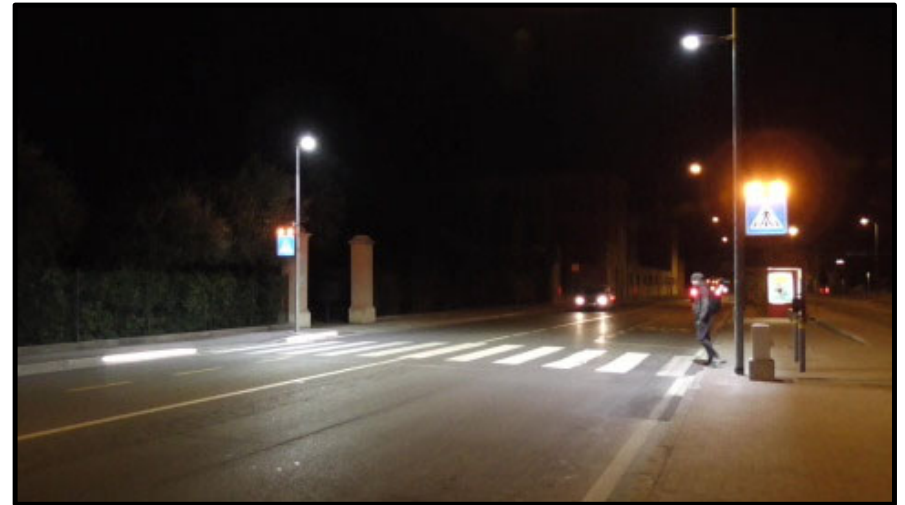

- Temporary lane closures will occur during off-peak hours
 - Flagger Operations
- Pedestrian traffic will be maintained at all times
- Access to properties along the corridor will be maintained at all times

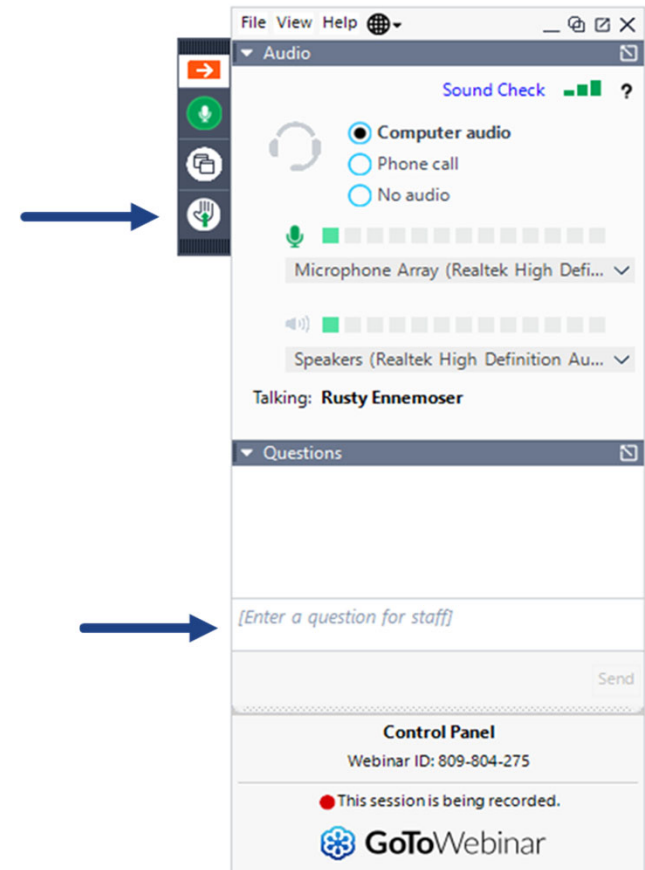
