PROJECT IMPROVEMENTS

- Creating a safer, more energy-efficient, and resilient transportation environment by upgrading lighting to LED fixtures and retrofitting existing light poles at 22 signalized intersections in St. Lucie, Martin and Palm Beach counties (see maps for specific locations, please note that installation activities will not occur in numerical order)
 - St. Lucie County
 - SR 615/25th Street in Ft. Pierce
 - SR A1A/Seaway Drive in Ft. Pierce
 - Martin County
 - SR 714/ Martin Downs Boulevard in Palm City
 - Palm Beach County
 - SR 5/US 1 in North Palm Beach
 - SR 710/Dr. MLK Jr. Boulevard in Riviera Beach
 - SR 882/Forest Hill Boulevard in West Palm Beach, Palm Springs, Lake Clarke Shores, Greenacres and Lake Worth Beach
 - SR 805/Dixie Highway in Lake Worth Beach
 - SR 7/US 441 in Lake Worth Beach
- Access to businesses and residences will be maintained at all times

TRAFFIC IMPACTS

- Single-lane closures are allowed on SR 615/25th Street and SR A1A/US 1, Monday through Friday, 6:00 a.m. to 4:00 p.m.
- Single-lane closures are allowed on SR 714/SW Martin Downs Boulevard and SW Mapp Road, Monday through Friday, 7:30 p.m. to 5:30 a.m.
- Single-lane closures are allowed on SR 5/US 1 at Lakeshore Drive/Golfview Road, Monday through Friday, 6:00 p.m. to 12:30 p.m.
- Single-lane closures are allowed on SR 710/Dr. MLK Jr. Boulevard at Australian Avenue, Monday through Friday, 6:30 a.m. to 4:30 p.m., except during school drop-off times
- Single-lane closures are allowed on SR 882/Forest Hill Boulevard, SR 805/Dixie Highway, and SR 7/US 441, Monday through Friday, 6:30 a.m. to 4:30 p.m., except during school drop-off times at SR 882/Forest Hill Boulevard intersections with Jog Road, Kudza Road, Davis Road, and SR 805/Dixie Highway
- To ensure motorist and pedestrian safety during the installation of the new light poles, brief detours on local roads of up to 24 hours will be in place at the following intersections:
 - SR 714/SW Martin Downs Boulevard at SW Mapp Road
 - SR 882/Forest Hill Blvd at Kudza Road
 - SR 805/Dixie Highway at 10th Avenue N
 - SR 805/Dixie Highway at 13th Avenue N
 - SR 805/Dixie Highway at Worthmore Drive/Fordham Drive

Advanced notice and detour routes will be provided to businesses, motorists and residents prior to detour implementation

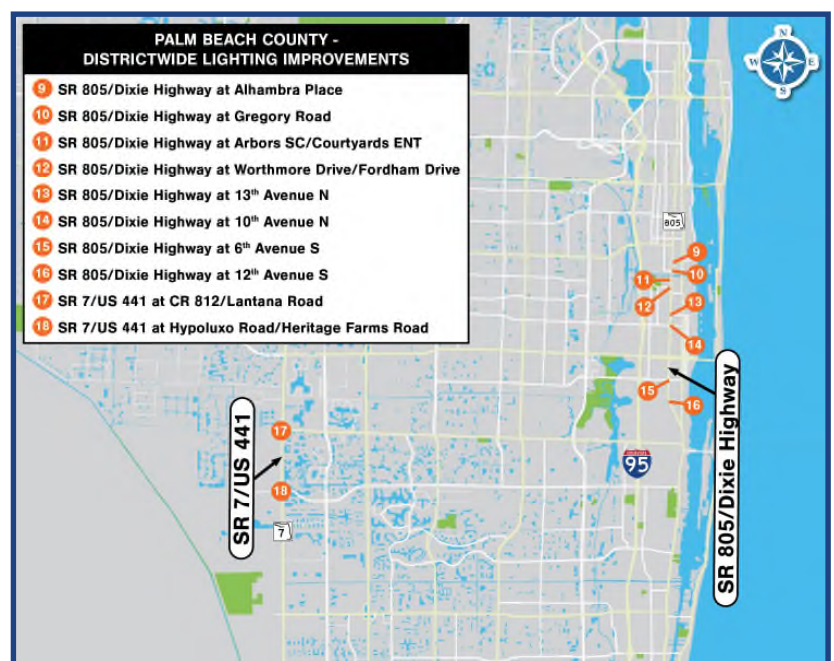
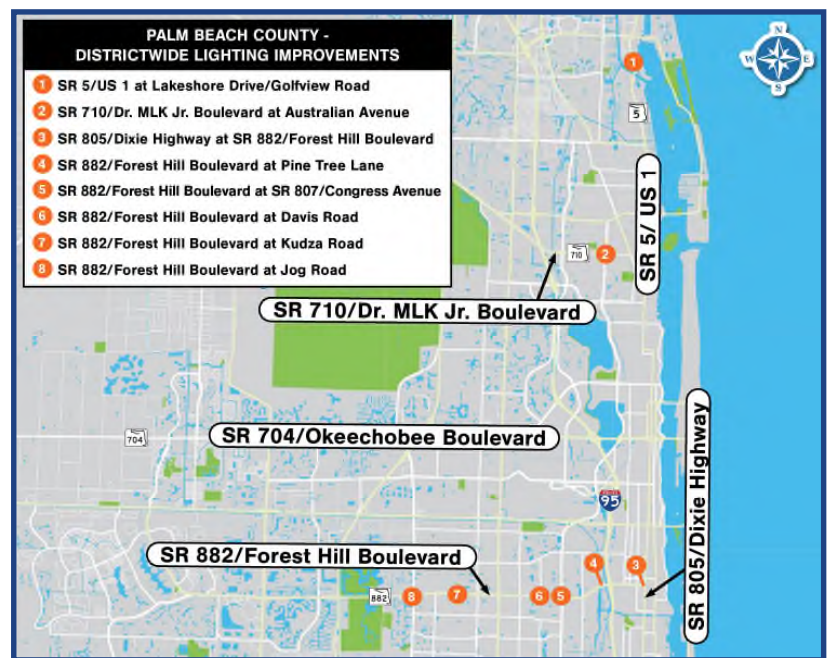
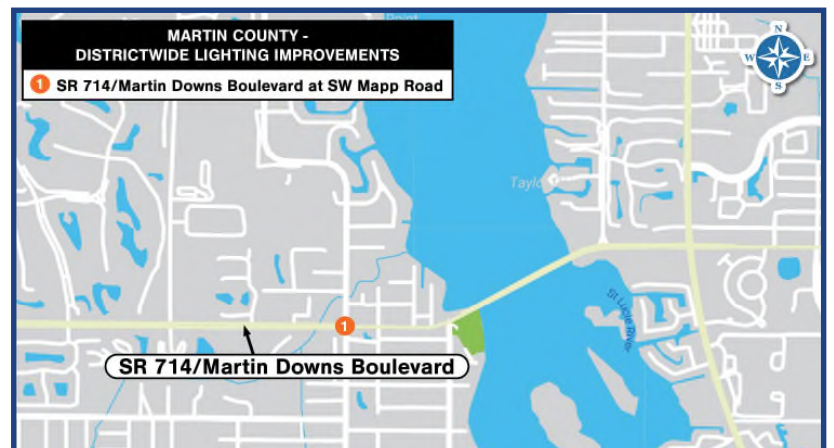
