#### PROPOSED IMPROVEMENTS

- Repave the existing pavement
- Reconstruct sidewalk
- Upgrade curb ramps to meet Americans with Disabilities Act (ADA) standards
- Upgrade pedestrian signals, intersection lighting, pavement markings, and signing to latest standards

#### **CONSTRUCTION IMPACTS**

- Temporary single lane closures during off-peak hours will be required.
- Milling and Resurfacing will take place during the night and be sequenced to reduce the effects of construction on the community
- Access to adjacent properties will be maintained at all times
