### SR 802/LAKE WORTH ROAD RESURFACING PROJECT

SR 802/Lake Worth Road from Raulerson Dr. to Palm Beach State College Entrance  
Palm Beach County, Florida

The Florida Department of Transportation (FDOT), District Four, will conduct a Public Meeting regarding proposed median modifications along SR 802/Lake Worth Road from Raulerson Drive to Palm Beach State College Entrance. The meeting will be conducted in a hybrid format with both virtual and in-person components. Both formats will begin at 6:00 p.m. with a presentation followed by a question-and answer session.

### PROPOSED IMPROVEMENTS

- Reconfigure existing full median openings to directional medians by constructing a raised median separator at the following intersections:
  - ◇ Cooley Court
  - ◇ Corrigan Court/Foss Road
  - ◇ Coconut Road
  - ◇ Gulfstream Road
  - ◇ Mar Mak Drive
- Close the existing westbound left turn at 3200 Block.
- Provide 7-foot separated bicycle lanes in both directions.

### MEDIAN MODIFICATION IMPACTS

- Existing left-turn movement from the side streets listed above will be eliminated.
- Existing left-turn movement will be accomplished by making a U-turn at the next intersection.

### BENEFITS OF MEDIAN MODIFICATION

- Reduces vehicular conflicts and improve safety conditions at unsignalized median openings.

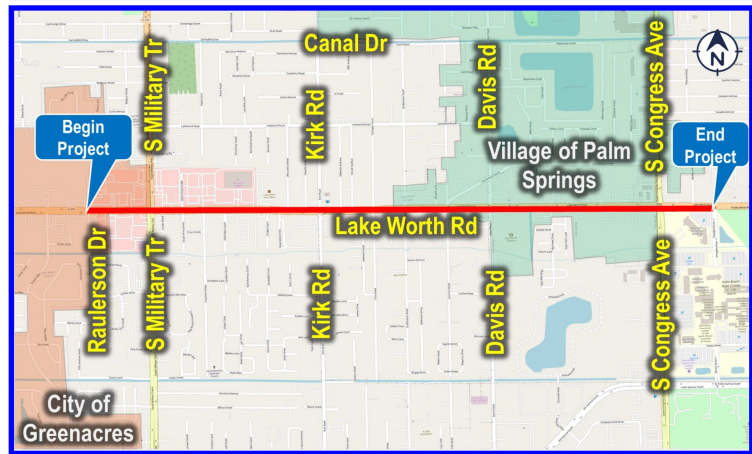
