### SR 786/PGA BOULEVARD OVER THE INTRACOASTAL WATERWAY BRIDGE PROJECT

The Florida Department of Transportation (FDOT), District Four, is pleased to provide information regarding the upcoming SR 786/PGA Boulevard bridge project over the Intracoastal Waterway in the City of Palm Beach Gardens.

Construction Cost: \$2,377,931    Construction Start Date: January 2022    Anticipated Completion: Summer 2022

#### PROJECT IMPROVEMENTS

- Installing erosion control materials in the channel under the SR 786/PGA Boulevard bridges (Bridge Nos. 930349 and 930106)
- Replacing submarine cable conduit that provides power and communication to the bridges' movable spans

#### TRAFFIC IMPACTS

- Lane closures may occur on PGA Boulevard from 7:00 p.m. to 2:30 p.m. Monday through Friday.
- Pedestrian detours will be in place during sidewalk closures on PGA Boulevard.
- Access to residences and businesses will be maintained at all times.
- Marine traffic will be maintained through the navigable waterway. Channel restrictions may occur.
