NW CORPORATE WAY AT CR 712/ MIDWAY ROAD CLOSURE EXTENDED THROUGH AUGUST 26, 2025

To ensure community and crew safety as we work to enhance the roadway and provide a safer and more resilient infrastructure, NW Corporate Road at CR 712/Midway Road will be closed around-the-clock through 5 p.m., Tuesday, Aug. 26, 2025, for roadway reconstruction. Signage will be in place to assist motorists. This closure was implemented on May 12. If weather or unforeseen circumstances arise, NW Corporate way will reopen by Friday, Aug. 29, 2025.

- Eastbound NW Corporate Way motorists will be detoured via eastbound CR 712/ Midway Road, southbound NW Milner Drive to westbound NW Corporate Way.
- Westbound NW Corporate Way motorists will be detoured via southbound NW Milner Drive to westbound NW Corporate Way.
- Access to businesses and residences will be maintained.
