



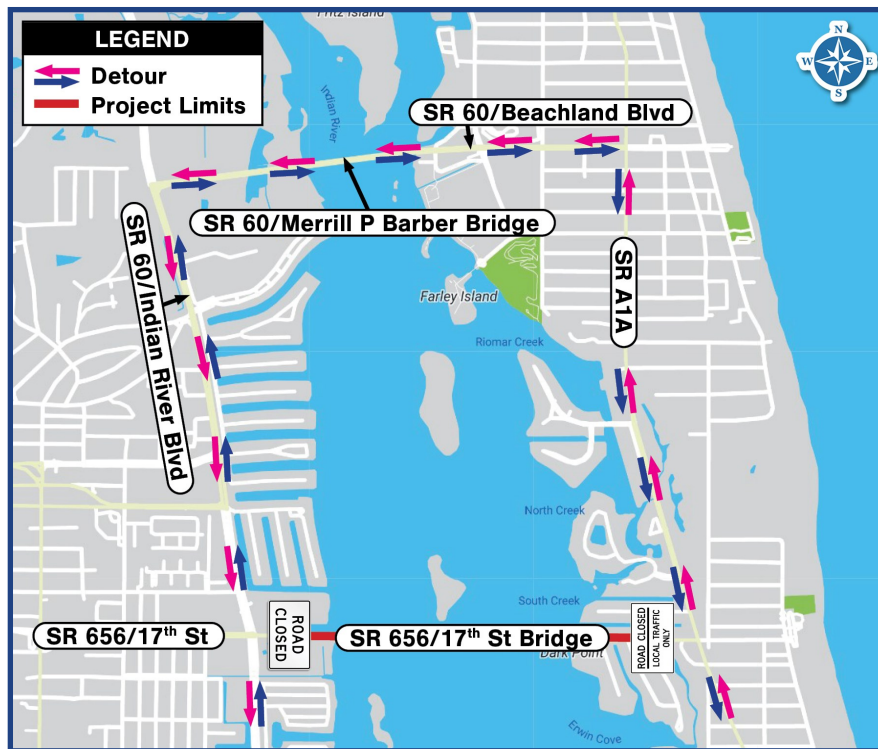

NIGHTLY CLOSURE OF SR 656/17th STREET BRIDGE FOR TRAFFIC SEPARATOR MAINTENANCE BEGINS OCT. 13, 2025

To ensure community and public safety as we work to enhance the roadway and provide a safer and more resilient infrastructure, eastbound and westbound traffic on SR 656/17th Street Bridge between SR A1A and SR 60/Indian River Boulevard, will be closed to traffic nightly, 9 p.m. to 5 a.m., Monday through Friday, beginning Monday, October 13, through Friday, October 17, for traffic separator maintenance throughout the bridge. Signage will be in place to assist motorists. Monday, October 20, through Friday, October 24, will be used as contingency dates if needed.

- Westbound motorists will be detoured via SR A1A and SR 60/Beachland Boulevard to SR 60/Indian River Boulevard.
- Eastbound motorists will be detoured via SR 60/Indian River Boulevard and SR 60/Beachland Boulevard to SR A1A.
