#### SR 5/US 1 Road RRR Project

The Florida Department of Transportation (FDOT) invites the community to a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming SR 5/US 1 RRR Project in the City of Stuart and unincorporated Martin County. The project limits are on SR 5/US 1 from north of Southeast Fischer Street to north of Southeast Decker Avenue. This project aims to enhance the safety, resiliency, and longevity of the infrastructure within our communities. Please see below for detailed meeting information.

**Construction Cost:** \$7.5 Million **Construction Start:** April 2025 **Estimated Completion:** Summer 2026

#### **PROJECT IMPROVEMENTS**

- Milling and resurfacing the existing roadway within the project limits to enhance safety and long-term resiliency
- Widening the bicycle lane by restriping it from 4 feet to 5 feet to increase safety
- Constructing new light poles with LED fixtures at signalized intersections to boost nighttime visibility
- Reconstructing existing sidewalk curb ramps throughout the project limits to enhance safety and connectivity for pedestrians
- Upgrading existing pedestrian signals at signalized intersections to improve push button accessibility
- Upgrading signage and pavement markings to enhance safety, functionality, and traffic operations

#### TRAFFIC IMPACTS

- Single and double-lane closures on SR 5/US 1 are permitted nightly during the following timeframes:
  - 9:00 p.m. to 6:00 a.m. within 600 feet of a signalized intersection
  - 8:00 p.m. to 6:00 a.m. outside 600 feet from a signalized intersection
- Access to and from bus stops will be maintained
- Business, pedestrian and residential access will be maintained at all times throughout construction


