Project Overview

Purpose: To extend the pavement's service life through milling and resurfacing while enhancing roadway safety along the SR 607/Emerson Avenue corridor for motorists, bicyclists, and pedestrians.

Length: 2.2 miles

Contractor: OHLA-USA, Inc.

Construction Start: January 2025

Cost: \$6.4 Million

Estimated Completion: Spring 2026

Scope of Work

Roadway Improvements

Roadway Improvements

- Milling and resurfacing the travel lanes to enhance safety and long-term resiliency
- Widening the existing 5-foot paved shoulder to 7-feet to enhance safety
- Upgrading signage and pavement markings to improve safety, functionality, and traffic operations

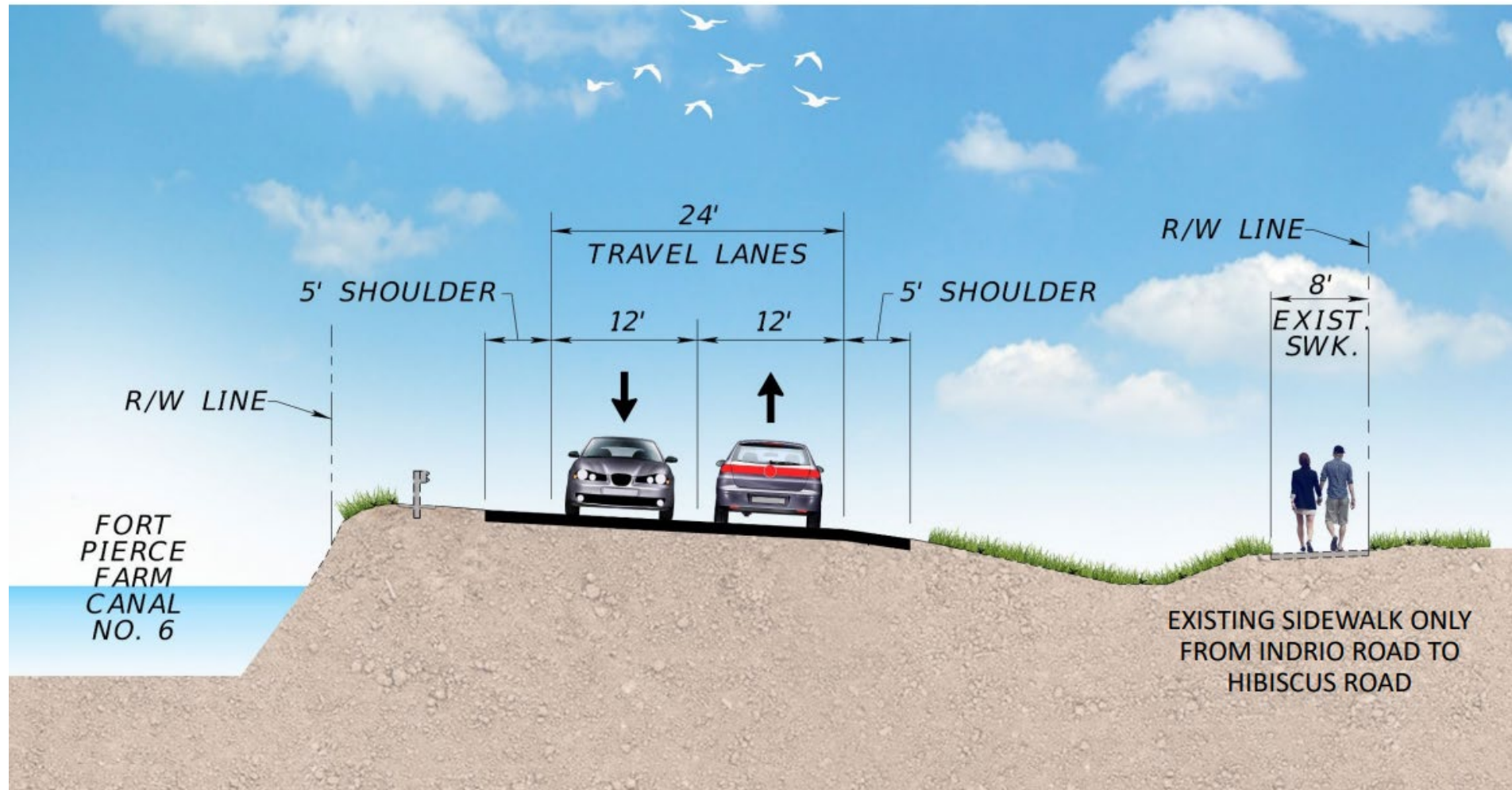

Pedestrian Improvements

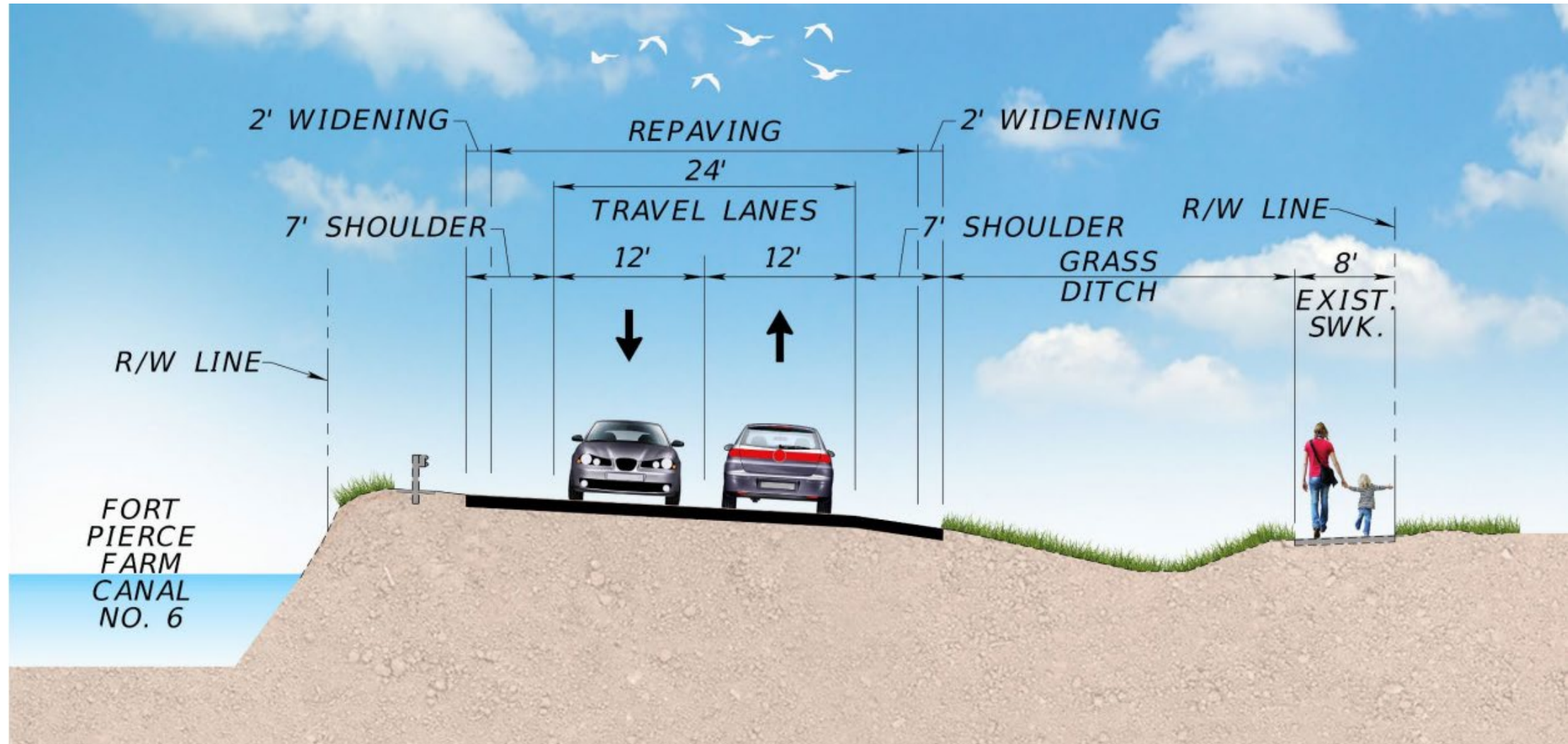
Pedestrian Improvements

- Constructing a sidewalk (varying from 6 to 12 feet in width) along the east side of SR 607/Emerson Avenue from Hibiscus Road to North Road to enhance safety and connectivity for pedestrians
- Upgrading curb ramps along existing sidewalks to enhance safety and connectivity for pedestrians
- Installing concrete bus concrete pads at two existing bus stops along northbound SR 607/Emerson Avenue, located approximately 300 feet south of Hibiscus Road and approximately 100 feet north of Belleair Avenue, to enhance safety, functionality, and long-term resiliency

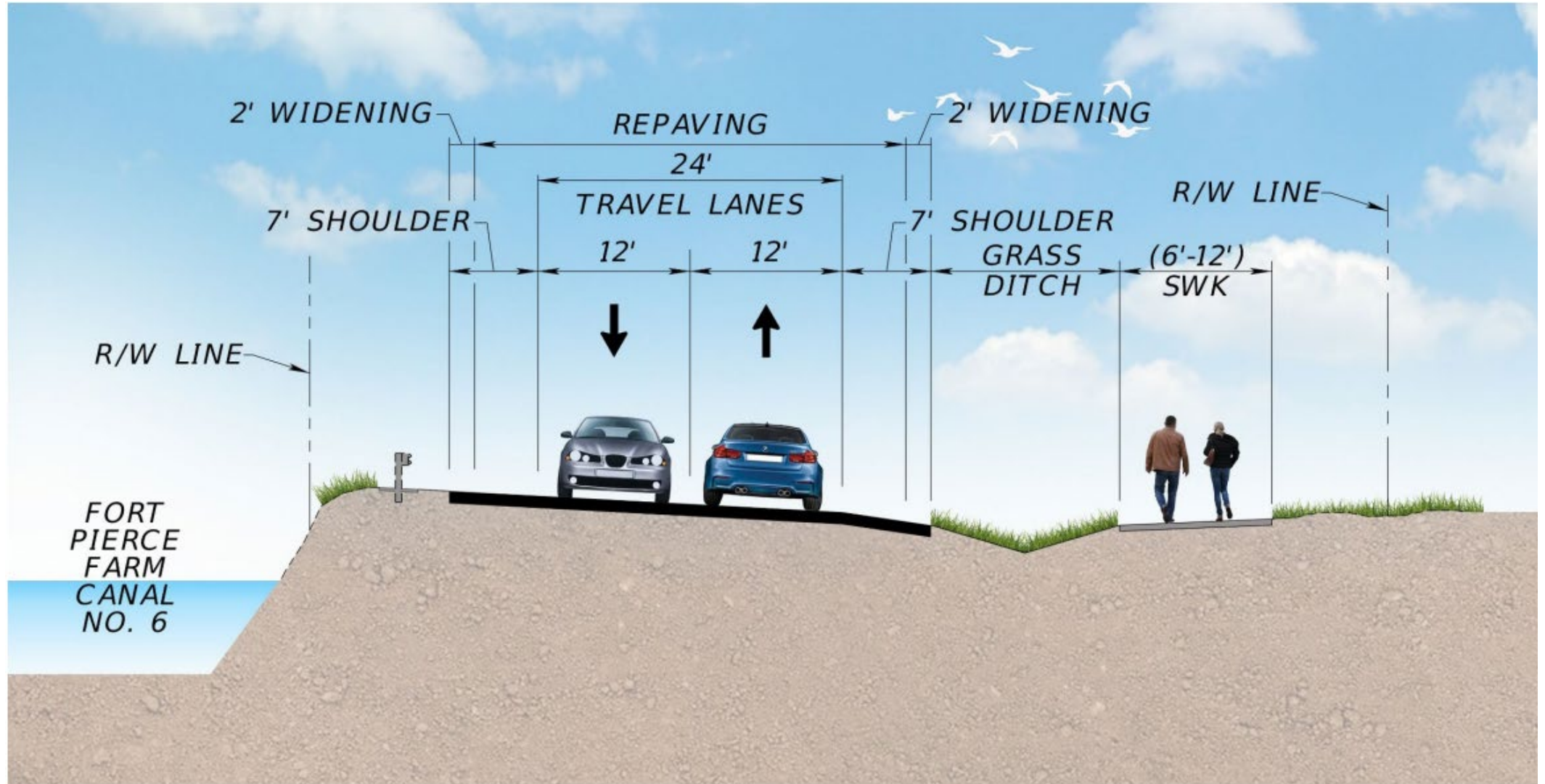
Existing Typical Section - SR 607/Emerson Avenue from north of SR 614/Indrio Road to south of 25th Street SW



Proposed Typical Section – SR 607/Emerson Avenue from SR 614/Indrio Road to Hibiscus Road

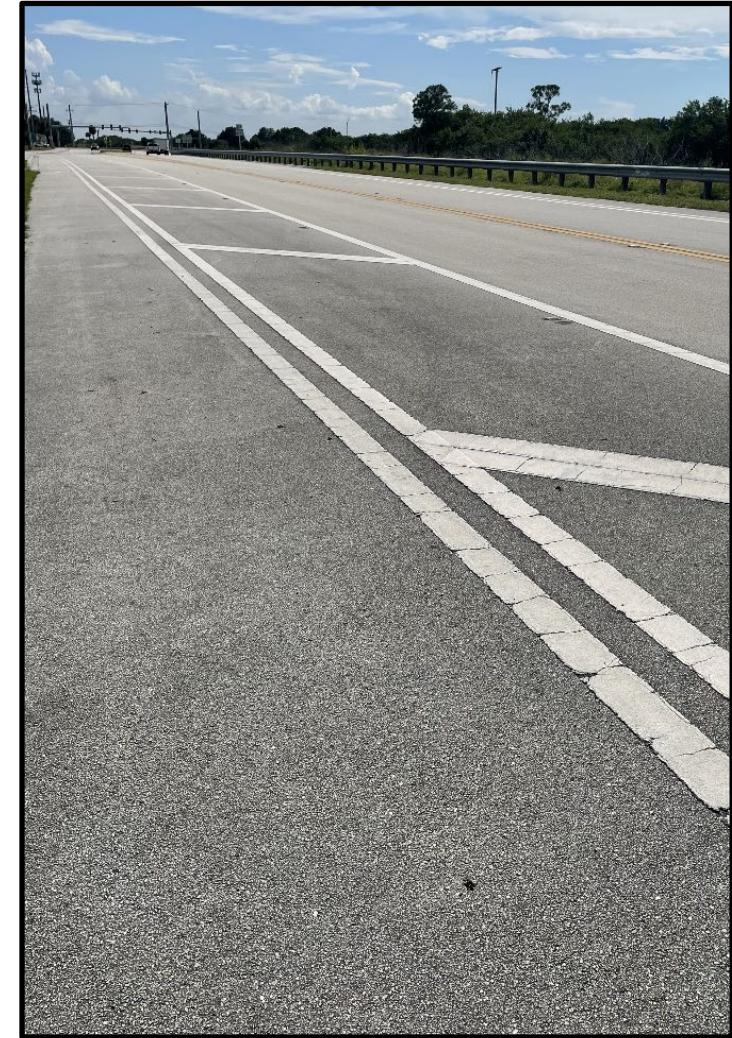


Proposed Typical Section – SR 607/Emerson Avenue from Hibiscus Road to south of 25th Street SW



Maintenance of Traffic:

- Residential, pedestrian, and business access will be maintained at all times
- Single-lane closures on SR 607/Emerson Avenue are permitted as follows:
 - Daytime, Monday through Sunday, from 8:00 a.m. to 8:00 p.m.
 - Nighttime, Monday through Sunday, from 8:00 p.m. to 8:00 a.m. for milling, resurfacing, and striping work

Maintenance of Traffic:

- The speed limit on SR 607/Emerson Avenue between SR 614/Indrio Road and Hibiscus Road will be reduced from 50 MPH to 45 MPH during construction
- The speed limit on SR 607/Emerson Avenue between Hibiscus Road and Deland Avenue will be reduced from 50 MPH to 40 MPH during construction
- The speed limit on SR 607/Emerson Avenue between Deland Avenue and 25th Street SW will be reduced from 50 MPH to 45 MPH during construction

Construction Phases

Phase 1 – Southbound SR 607/Emerson Avenue:

- Perform clearing and grubbing
- Install temporary pavement markings and remove all pavement markings that will conflict with the next phase of construction

Construction Phases

Phase 2 – Northbound SR 607/Emerson Avenue:

- Install and maintain the low-profile barrier wall
- Construct roadway and shoulder widening
- Perform clearing and grubbing
- Install drainage structures
- Re-grade the swales
- Construct curb and gutter, sidewalk, curb ramps, and guardrail
- Install temporary pavement markings and remove all markings that will conflict with the next phase of construction

Construction Phases

Phase 3 – Northbound and Southbound SR 607/Emerson Avenue:

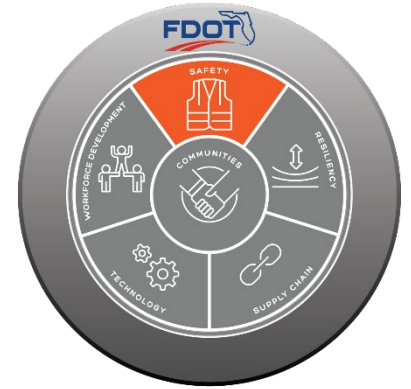
- Mill and resurface the roadway one lane at a time
- Construct final friction course throughout resurfacing and widening limits
- Install rumble strips, signage, and pavement markings

Safety and Local Coordination

- **Public Safety is our Top Priority!**
 - **Work Zone Signage & Maintenance of Traffic**
 - Advanced warning and project signage will be placed throughout the construction corridor to alert the traveling public
 - **Local Agency & Stakeholder Coordination**
 - The project team will continue working closely with local stakeholders including local municipalities, schools, neighborhoods and other local agencies to ensure safety standards are met and impacts to the public are minimized in any way possible
 - **Emergency vehicles will be provided access at all times**

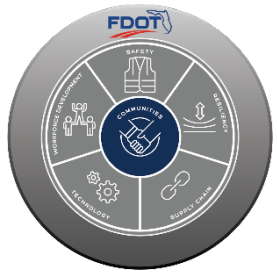
