State Road (SR) 714/ SW Martin Highway Between SW Citrus Boulevard and SW Leighton Farm Avenue to Undergo Intermittent Nighttime Closure through February 15, 2025

The Florida Department of Transportation (FDOT) is pleased to provide information for the SR-714/SW Martin Highway Widening Project in Martin County. The goal of this project is to improve the regional connectivity, safety, and resiliency of the transportation network for our local communities. # ROADWAY AND PIPE INSTALLATION WORK ON SR 714/SW MARTIN HIGHWAY BETWEEN SW CITRUS BOULEVARD AND SW LEIGHTON FARM AVENUE

- To ensure community and crew safety as we work to enhance the roadway and provide a safer and more resilient infrastructure, SR 714/ SW Martin Highway between SW Citrus Boulevard and SW High Meadows Boulevard will be intermittently closed, as needed, through approximately 5 p.m., Saturday, February 15, 2025, for roadway reconstruction. This full closure was implemented on May 1, 2024, and traffic will continue to be detoured via SW High Meadows Boulevard, SR 76/ S Kanner Highway, SW 96th Street, and SW Citrus Boulevard. If weather or unforeseen circumstances arise, SR 714/ SW Martin Highway between SW Citrus Boulevard and SW High Meadows Boulevard will reopen by Saturday, Feb. 22.
- Eastbound SR 714/ SW Martin Highway traffic will be detoured via SW Citrus Boulevard, SW 96th Street, SR 76/ SW Kanner Highway, enter the SR 9/ I-95 northbound on ramp from SW Kanner Highway, exit SR 9/ I-95 at High Meadows Avenue (Exit 102), High Meadows Avenue to SR 714/ SW Martin Highway.
- Westbound SR 714/ SW Martin Highway traffic will be detoured via High Meadows Avenue, enter the SR 9/ I-95 southbound on ramp from High Meadows Avenue, exit SR 9/ I-95 at SR 76/ SW Kanner Highway (Exit 101), SW 96th Street, and SW Citrus Boulevard to SR 714/ SW Martin Highway.
- Local traffic on SR 714/ SW Martin Highway between SW Leighton Farm Avenue and SW Citrus Boulevard will be escorted through the work zone by project personnel and offduty police officers.

### **PROJECT IMPROVEMENTS**

- Widen SR-714/SW Martin Highway from a two-lane undivided rural roadway to a four-lane divided urban roadway.
- Widen the bridge over Florida's Turnpike.
- Construct seven-foot buffered bike lanes and six-foot sidewalks on both sides of the roadway.
- Realign SW Leighton Farm Avenue further west to line up with SW Deggeller Court and create a four-legged intersection.
- Install a new closed-drainage system with a retention pond.
- Install signing, signalization, and lighting upgrades.
