The Florida Department of Transportation (FDOT), District Four, is pleased to provide information about the proposed Resurfacing, Restoration, and Rehabilitation improvements along SR 615 from Avenue Q to St. Lucie Boulevard in St. Lucie County, Florida. No public information workshop scheduled for this project.

### PROPOSED IMPROVEMENTS

- Mill and resurface the existing pavement.
- Pedestrian sidewalk curb-ramp reconstruction.
- Replace pavement markings and upgrade signing to current standards.
- Lighting upgrades at the intersection of Juanita Ave and St. Lucie Blvd to improve pedestrian lighting at the crosswalks.
