The Florida Department of Transportation (FDOT), District Four, will conduct a Public Meeting regarding the proposed improvements along SR 76/Kanner Highway from north of SR 710/Warfield Blvd/MP 12.487 to MP 14.400. This Public Meeting will be offered in two different formats: virtual and in-person. The Public Meeting will have representatives available to answer questions. ### PROPOSED IMPROVEMENTS

- Repaving and restriping the existing roadway and shoulders
- Widening the existing shoulders from 10 feet (4-ft. paved) to 12 feet (7-ft. paved)
- Replacement of deficient signing and installation of new pavement markings
- Installation of audible vibratory treatment along the centerline and edge lines of the roadway
- Extending the existing guardrail at selected locations to address canal hazards
- Regrading the existing linear ditch in front of St Lucie Mobile Home Park
- Replacing existing TMS loops

### CONSTRUCTION IMPACTS

- Work will be scheduled in phases to reduce effects of construction on the community
- Temporary lane closures will take place during non-peak hours to reduce impact to the public
- Access to businesses and private properties will be maintained at all times during construction

- Anticipated Completion: **Summer 2024**
- Construction Cost Estimate: **\$2.6 Million**
