PROJECT IMPROVEMENTS

- Repave the existing travel lanes with the exception from SW Joan Jefferson Way to NW Wright Boulevard.
- No work is proposed on the Roosevelt Bridge.
- Construct sidewalks where feasible to fill in missing gaps.
- Install new pavement markings.
- Upgrade pedestrian pushbutton detectors at signalized intersections.
- Upgrade lighting at signalized intersections.
- Minor drainage improvements.

CONSTRUCTION IMPACTS

- All work will be done in phases to reduce the impact of construction to the community.
- Daytime temporary lane closures during non-peak hours will occur.
- There will be no complete road closures.
- Access to businesses and residences will be maintained at all times.
