TRAFFIC DETOUR OF DELAND AVENUE AT SR 607/EMERSON AVENUE EXTENDED THROUGH SEPT. 19

To ensure community and crew safety as we work to enhance the roadway and provide a safer and more resilient infrastructure, Deland Avenue at SR 607/Emerson Avenue will be closed around-the-clock through 5 p.m., Friday, September 19, 2025, for the construction of a retaining wall. This closure was first implemented on Aug. 25. If weather or unforeseen circumstances arise, Deland Avenue will be opened by Friday, September 26, 2025.

- **Northbound** SR 607/Emerson Avenue to Deland Avenue motorists will be detoured via eastbound Lakeland Boulevard to south on Lilyan Parkway to Deland Avenue.
- **Southbound** SR 607/Emerson Avenue to Deland Avenue motorists will be detoured via eastbound Hibiscus Road to northbound Lee Boulevard to Deland Avenue.
- Access to local residences on Deland Avenue will be maintained.
