State Road (SR) A1A Resurfacing, Restoration, and Rehabilitation (RRR) from South of Jasmine Lane to North of SR 60/Beachland Boulevard (443996-1-52-01) and intersection improvements at various locations along SR A1A and SR 5/US-1 (440822-1-52-01)

Indian River County, Florida

The Florida Department of Transportation (FDOT), District Four, will conduct a Public Meeting regarding the above referenced project. This Public Meeting will have an open house and a presentation, followed by a question/comment period. PROPOSED IMPROVEMENTS

The scope of work for project 443996-1-52-01 includes:

- Repaving and restriping existing asphalt pavement
- Widening the roadway to accommodate a 7-foot buffered bicycle lane
- Constructing a 6-foot sidewalk on the east side (Northbound direction)
- Upgrading existing drainage
- Rehabilitation of existing curb ramps to Americans with Disabilities Act (ADA) standards
- Adding two signalized pedestrian mid-block crossings at Iris Lane and Dahlia Lane
- Upgrading pedestrian signal and lighting at the intersection of SR A1A and SR 60/Beachland Blvd.
- Enhancing signing throughout the corridor

The scope of work for project 440822-1-52-01 includes:

- Constructing a southbound right turn lane at the intersection of SR 5/US-1 and 8 Street
- Extending the southbound right turn lanes at the intersections of SR A1A and the 17 Street Causeway and SR A1A and SR 60/Beachland Blvd.
- Upgrading existing drainage

CONSTRUCTION IMPACTS

- Work will be phased to reduce impacts to the community
- Temporary lane closures are anticipated during non-peak hours

9:30 am to 3:30 pm Monday thru Sunday 9:00 pm to 5:30 am week nights

- Repaving and restriping will be performed at night
- Access to all businesses and homes will be maintained at all times
