State Road (SR) 9/I-95 northbound exit ramp to westbound SR 68/Orange Avenue St. Lucie County, Florida

PROJECT PURPOSE

To enhance safety by repaving the existing ramp and applying a high-friction surface treatment to reduce potential skidding by vehicles.

PROJECT IMPROVEMENTS

- Milling and resurfacing existing ramp roadway
- Overlay ramp with high friction surface treatment to improve safety by reducing potential skidding by vehicles
- Widen existing left shoulder from 2-feet paved to 4-feet paved creating a larger refuge area for broken-down
- Replace and upgrade signs and pavement markings to meet current standards and increase reflectivity
- Upgrade existing lighting to LED fixtures to improve visibility for nighttime users

CONSTRUCTION IMPACTS

- Northbound to Westbound Ramp closures will be permitted as
 - Nighttime closure only, Sunday through Thursday, 8:00 p.m. to 6:00 a.m., for approximately 3 weeks.
- Detour using Northbound to Eastbound Ramp. Follow Jenkins Rd north to Loop Rd to turn back west. Approximate 1.25 mile route.
