PROPOSED IMPROVEMENTS

- Resurface pavement
- Add bicycle lanes within the project limits:
 - 5 feet wide from NW Jensen Beach Boulevard to NW Sunset Boulevard
 - 7 feet wide from NW Sunset Boulevard to the Martin County/St. Lucie County Line
- Upgrade curb ramps to meet Americans with Disabilities Act (ADA) standards
- Upgrade pedestrian signals, intersection lighting, pavement markings, and signing to latest standards

CONSTRUCTION IMPACTS

- Milling and resurfacing will be performed during the nighttime
- All work will be done in phases to reduce the impact of construction to the community
- Occasional single lane closure will occur during construction
- Driveway and street access will be maintained throughout construction
