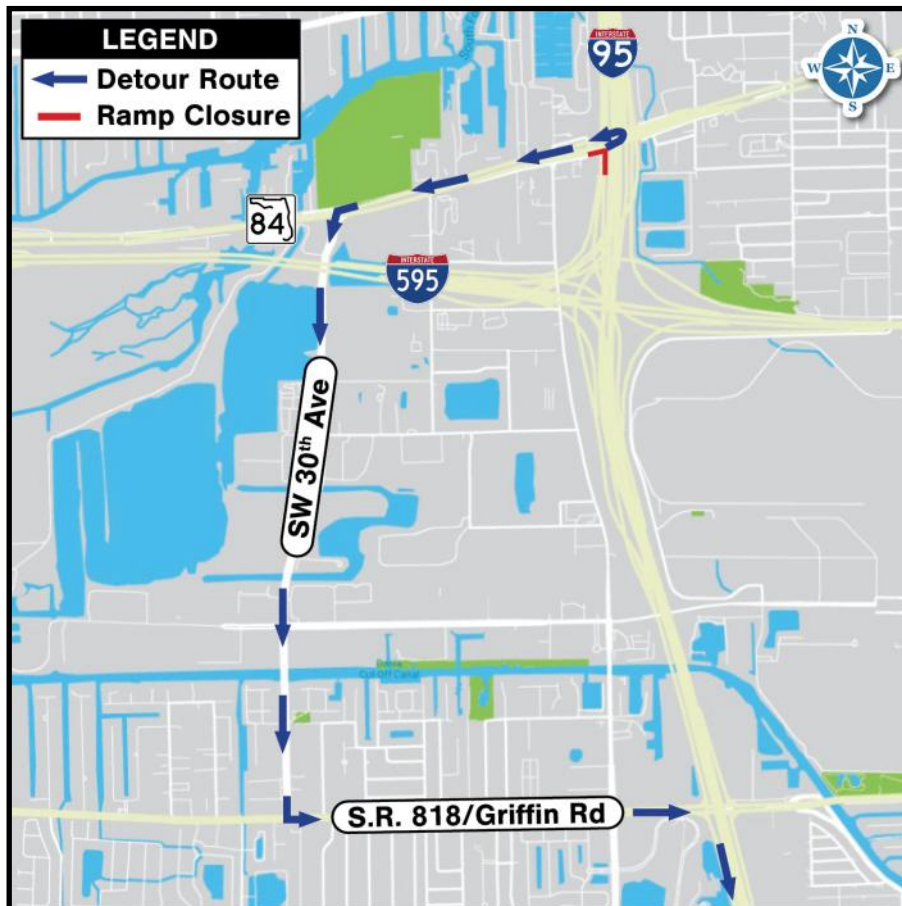

THE SOUTHBOUND S.R. 9/I-95 ENTRANCE RAMP FROM EASTBOUND S.R. 84/MARINA MILE BLVD TO CLOSE APRIL 7

The southbound S.R. 9/I-95 entrance ramp from S.R. 84/Marina Mile Boulevard will be closed to traffic overnight, from 10:30 p.m. until 5 a.m., Tuesday, April 7. This closure is necessary to allow crews to safely perform directional bore operations. Traffic will be detoured via the frontage Road to westbound S.R. 84/Marina Mile Boulevard, southbound SW 30th Avenue, and eastbound S.R. 818/Griffin Road to access southbound S.R. 9/I-95. Wednesday, April 8 and Thursday, April 9 will be reserved as contingency nights if needed. FHP will be on-site, and signage will be in place to assist motorists.
