NORTHBOUND S.R. 9/I-95 EXIT RAMP (EXIT 29B) TO WESTBOUND S.R. 838/SUNRISE BLVD TO CLOSE AUG 3 TO AUG 7

The S.R. 9/I-95 northbound exit ramp (Exit 29B) to westbound S.R. 838/Sunrise Boulevard will be closed to traffic nightly, 8 p.m. until 6 a.m., Monday, August 3, through Friday, August 7 for drainage, earthwork, and paving activities.

During this closure, northbound S.R. 9/I-95 traffic will be detoured via the S.R. 9/I-95 exit ramp (Exit 29A) to eastbound S.R. 838/Sunrise Boulevard, to southbound S.R. 845/Powerline Road/NW 9th Avenue, to westbound NW 6th Street/Sistrunk Boulevard, to northbound NW 27th Avenue, and westbound S.R. 838/Sunrise Boulevard. Signage will be in place to assist motorists.

The **Florida Highway Patrol (FHP)** will be on site to assist with traffic control, and detour signage will be in place to guide motorists safely through the area.
