S.R. 5/U.S. 1 RESURFACING, RESTORATION, AND REHABILITATION PROJECT

The Florida Department of Transportation (FDOT) is pleased to provide information regarding the upcoming S.R. 5/U.S. 1 Resurfacing, Restoration, and Rehabilitation Project. The project limits are on S.R. 5/U.S. 1 from Belvedere Road to south of S.R. 704/Okeechobee Boulevard in the City of West Palm Beach. This project aims to enhance the safety, travel efficiency, resiliency and longevity of the infrastructure for our communities. Please see below for detailed meeting information.

Construction Cost: \$3.9 Million

Construction Start: May 2026

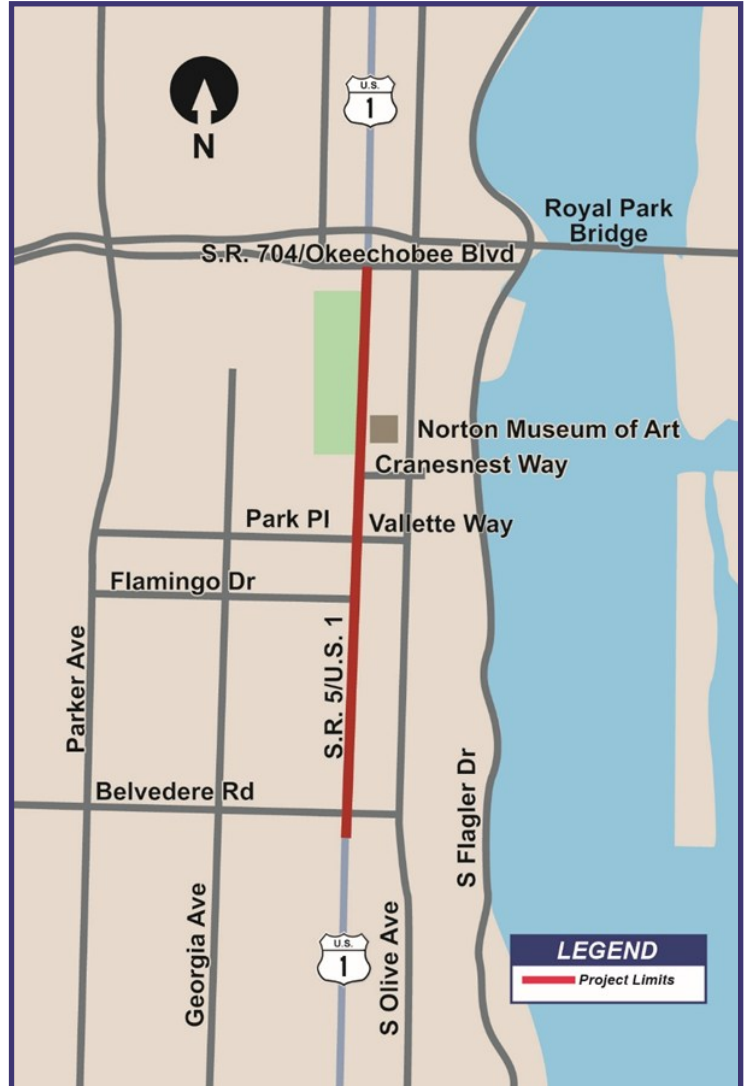
Estimated Completion: Spring 2027

PROJECT IMPROVEMENTS

- Minor reconstruction, and milling and resurfacing the roadway to enhance infrastructure resilience and safety.
- Reconstructing curb ramps to meet ADA criteria and replacing portions of the existing sidewalk to improve pedestrian safety, connectivity, and use.
- Upgrading signing and pavement markings to enhance visibility and safety.
- Replacing drainage structures within driveways.
- Adding a new signalized mid-block crosswalk north of Vallette Way.
- Upgrading pedestrian signalization at Belvedere Road and Flamingo Drive and the crosswalk north of Cranesnest Way.
- Installing overhead flashing beacons within the school zone north and south of Flamingo Drive.
- Upgrading lighting to LED fixtures and installing a new light at Flamingo Drive.

TRAFFIC IMPACTS

- Lane closures will take place along S.R. 5/U.S. 1 in both directions at various times.
- Northbound lane closures are allowed during:
 - 8:00 p.m. to 7:00 a.m. at Belvedere Road
 - 10:00 a.m. to 7:00 a.m. at Flamingo Drive
 - 8:30 p.m. to 7:00 a.m. at S.R. 704/Okeechobee Boulevard
- Southbound lane closures are allowed during:
 - 8:00 p.m. to 8:30 a.m. at Belvedere Road
 - 8:00 p.m. to 3:00 p.m. at Flamingo Drive
 - 7:30 p.m. to 11:30 a.m. at S.R. 704/Okeechobee Boulevard
- Lane closures are allowed outside of the intersections from 6:30 p.m. to 3:30 p.m.
- The northbound outside lane along S.R. 5/U.S. 1 will be closed continuously during drainage operations.
- Detours are permitted, 10:00 p.m. Friday until 9:00 p.m. Sunday for roadway reconstruction, and 8:00 p.m. to 6:00 a.m., Monday through Thursday for overhead sign installations.
- Sidewalk, business, and residential access will be maintained at all times.
