S.R. A1A/S. COUNTY ROAD AT WORTH AVENUE INTERSECTION — NIGHTTIME CLOSURES IN EARLY SEPTEMBER 2026

Beginning Thursday night, Sept. 2, 2026, nighttime intersection closures with detours may be in place from 8 p.m. until 6 a.m. on S.R. A1A/S. County Road at Worth Avenue to install conduit for traffic signals and street lights. Once underway, work is expected to be performed for approximately three (3) nights, Sunday through Thursday nights. However, work will not be performed on Sunday night, Sept. 6, or Monday night, Sept. 7, due to the Labor Day Holiday.

Once work is completed at Worth Avenue, these operations are expected to move to the S.R. A1A/S. County Road and Peruvian Avenue intersection. Please note, only one intersection within the project corridor on S.R. A1A/S. County Road from Hammon Avenue/Golfview Road to S.R. 704/Royal Palm Way will be closed at a time. These nightly operations for conduit installation can be expected through mid-September 2026.

S.R. A1A/S. County Road traffic at Worth Avenue will be detoured as follows:

- Northbound traffic on S.R. A1A/S. County Road may detour via eastbound Hammon Avenue to northbound S. Ocean Boulevard to westbound Chilean Avenue to northbound S.R. A1A/S. County Road
- Southbound traffic on S.R. A1A/S. County Road may detour via eastbound Peruvian Avenue to southbound S. Ocean Boulevard to westbound Hammon Avenue to southbound S.R. A1A/S. County Road
- Pedestrian detours will be in place at the intersection; please follow directional signage as marked
- Please use caution, drive safely, and allow for extra travel time as needed
