SUN Trail Improvements Project

In partnership with the Florida Department of Environmental Protection, City of Fort Pierce, St. Lucie County, and the St. Lucie County Transportation Planning Organization, the Florida Department of Transportation (FDOT) is pleased to announce the construction of the newest segment of the Shared-Use Nonmotorized (SUN) Trail Network which will be located within the Savannas Preserve State Park. In advance of the construction, FDOT will be hosting both virtual and in-person public information meetings to discuss the project details. We invite you to learn more about this exciting project and the efforts to build a connected SUN Trail Network. The meetings will be held on July 10, 2024. Construction Cost: \$5.82 million **Construction Start:** July 2024 **Estimated Completion:** Late 2025

PROJECT IMPROVEMENTS

- This segment of the Shared-Use Nonmotorized (SUN) Trail Network will be located within the Savannas Preserve State Park. The SUN Trail project improvements consist of constructing approximately 4.2 miles of 10-foot wide (8-feet where constrained) accessible multi-use trail.

TRAFFIC IMPACTS

- Single-lane closures are permitted during the daytime, Monday through Sunday, 9:00 a.m. to 5:00 p.m., on the following streets:
 - Easy Street
 - Buchanan Drive
 - Pinetree Drive
 - Palmetto Drive
 - Silver Oak Drive
 - Seagrape Drive
 - Myrtle Drive
 - Sunset Boulevard
 - County Road (CR) 712/Midway Road


