



## FLORIDA DEPARTMENT OF TRANSPORTATION INVITES YOU TO A PUBLIC MEETING

### RESURFACING PROJECT

State Road (S.R.) A1A from Sheridan Street to East Dania Beach Boulevard  
Broward County, Florida  
Financial Project ID: 448402-1-52-01

The Florida Department of Transportation (FDOT) will conduct a public meeting for the above referenced project within Broward County. This public meeting will be offered in-person and virtually simultaneously. The public meeting will have representatives available to answer questions. Project information will be available for public viewing. Questions and comments may be submitted prior to the meeting by contacting the Project Manager, Vandana Nagole. **PURPOSE OF PROJECT:** Repave and restripe the existing roadway to extend the service life of the pavement and enhance safety for motorists, pedestrians and bicyclists.

### PROPOSED IMPROVEMENTS

- Repave the existing roadway to improve the resiliency of our infrastructure.
- Widen the roadway pavement 3 feet on both sides to provide seven-foot buffered bike lanes to better accommodate cyclists who wish to use the roadway.
- Replace areas of deteriorated pavement to improve safety for motorists.
- Modify curb ramps to comply with the American Disabilities Act (ADA) to facilitate improved access for users with disabilities.
- Replace and upgrade signs and pavement markings to meet current standards and increase reflectivity.

### CONSTRUCTION IMPACTS

- Work will be done in phases to reduce the effects of construction on the community.
- Flagging operations will be in place while repaving and detours will be utilized while areas of deteriorated pavement are replaced.
- Access to businesses and residences will be maintained during construction.
- Another public meeting (Construction Open House) will be held prior to construction. Detailed information about how to keep informed of potential construction impacts will be provided at that meeting.

- Anticipated Construction Start: **Winter 2027**
- Anticipated Construction End: **Winter 2028**
- Estimated Construction Cost: **\$2 Million**

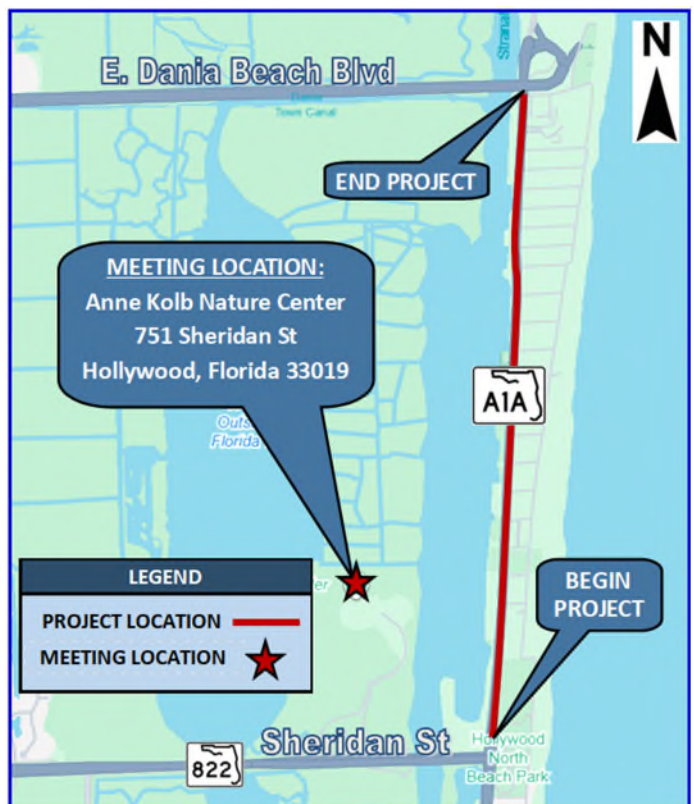
